Message from President Sharon Stoltz

This school year has meant changes for all of us with the new combined collective agreement put into place. Some changes of the CA that have affected us seem drastic and unfair, but we have to remember that the overuse of sick time affects us all and that our employer has to take into account funds to cover sick days used by employees when negotiating the CA. The funds to cover sick days when calculated over a school year can mean... staff shortages and filling positions due to no money, no subs resulting in short staff, no increases to wages and benefits. Let's all work hard to help maintain these benefits and positions by making wise choices when using sick time. Spring of 2015, Local 829 will again begin the process of negotiations for a new collective agreement with the expiration date of the old one being August of that year.

I am extremely proud of the members of Local 829 for their support for our campaign of *CUPE Brings a Child a Smile*. The work that is being done on your behalf to promote positive interactions and giving back to the community has received recognition from our city, as well as at the provincial and federal levels. CUPE Local 829 Support Staff should be proud as the committee that has been looking after this campaign made it happen and have planted roots that will continue to grow in the future. Hats off to Christina Schmidt and Angie Gackle for their work promoting such a worthwhile cause.

Phase one of the campaign kicked off with placing two helmets in twenty Public, Catholic and Redcliff elementary schools. Funding is in place to bring that total to a minimum of six helmets in each school, as well as starting the process of getting donated skates sharpened in the fall. The committee felt that this project promoted the need for skating at the school level for children that might not ever get that

chance to do so otherwise and the cost required for proper skating gear.

The second part of the campaign we chose was our support for the *Phoenix Safe House*. Before Christmas, we met with the staff from the safe house and the need for pyjamas was brought to our attention. One lady that had used the safe house had emailed them back thanking them and she expressed her gratitude for the memory of receiving a pair of pj's from the house the night she had arrived and how much it meant to her. *Phoenix Safe House* can give out 5 or more pair a week depending on circumstances and intakes. In January our local presented them with 150 pairs and we plan to continue with this campaign on a yearly basis. Watch for info and donation bins set up again in the fall. At this time, we are now collecting shampoo, toothpaste, diapers, wipes or any other necessities that you may feel would benefit woman and children that require the services of the *Phoenix Safe House*. CUPE Local 829 helps the families we work with every day to build a better tomorrow.

Our website is up and running at www.829.cupe.ca with links to access the collective agreements and information to keep you informed on what's happening in our local, in the province and in Canada with CUPE. The attack on pensions has been ongoing as well as the cuts to education that have affected us all. CUPE continues to fight these fights daily at all levels.

This past month we honoured our retirees with a supper and awards night at Medicine Hat Golf and Country Club. The evening was a huge success.

In closing, I would like to thank each and every one of you for the work you do every day in our schools. Whether you are cleaning the schools, looking after the offices or working directly with the children.....you are important. The time and energy that is needed daily, is at a maximum some days, but you continue on, to make a difference in the life of a child.


